2007: A YEAR OF CHANGE

2007 was a great year for the Dental Foundation of Oregon (DFO). We raised \$281,350 from our generous donors and successful fundraising events, and distributed \$73,900 in grant monies to worthy causes throughout the state.

After re-examining our goals and direction, we adopted a new name and refocused our mission statement to concentrate on our state's most vulnerable population; its children. In the summer, we launched an innovative branding campaign to reflect these changes.

In addition to funding worthwhile community programs came a new goal: to provide dental services directly to children in the rural areas of Oregon via a mobile dental clinic. A unique collaboration and partnership between the foundation, OEA Choice Trust and The ODS Companies resulted in the Tooth Taxi, which will begin to provide services in fall 2008. You can read more about this extraordinary new program on the following page.

Your continued support is invaluable to our organization's growth, our fight against the dental crisis in our state, and ultimately to the health and welfare of Oregon's children.

MOBILE DENTAL CLINIC BRINGS HOPE TO RURAL CHILDREN IN NEED OF DENTAL CARE

Much of 2007 was spent planning the purchase and implementation of a mobile dental clinic — the Tooth Taxi — which broadens the scope of the foundation's work by providing direct-service dental care to children throughout rural Oregon.

The foundation purchased the van in mid-January 2008, in partnership with the OEA Choice Trust and The ODS Companies. The 38-foot van has been customized and outfitted with two operatory units, state-of-the-art equipment and a waiting room.

The Tooth Taxi will be modeled after South Dakota's dental van, which has provided \$2 million in dental care to 5,000 children during its three years of operation.

Spending up to one week at a time at a rural school, the Tooth Taxi will be providing screenings, cleanings, sealants, X-rays, fillings, minor oral surgery and oral health education.

The Tooth Taxi program will be overseen by Dr. Bill Ten Pas, ODS senior vice president of dental services, and Mary Daly, the program manager.

The addition of a mobile dental clinic in Oregon provides a unique opportunity for dental professionals to give back to the community.

The Tooth Taxi will need volunteer dentists, dental hygienists and assistants to provide care and help improve oral health for Oregon's children. The foundation hopes for a generous outpouring of support for this very worthy program.

Outstanding Dental Program

Children's Dental Center
at the Creston School

This award recognizes a community dental clinic or education program that demonstrates innovation and creativity in the design or delivery of services.

This year's award recipient is the Assistance League of Portland's Children's Dental Center at the Creston School. This clinic is funded by the Assistance League of Portland to provide free dental services to eligible school children in Portland Public Schools.

Dr. Dale Canfield

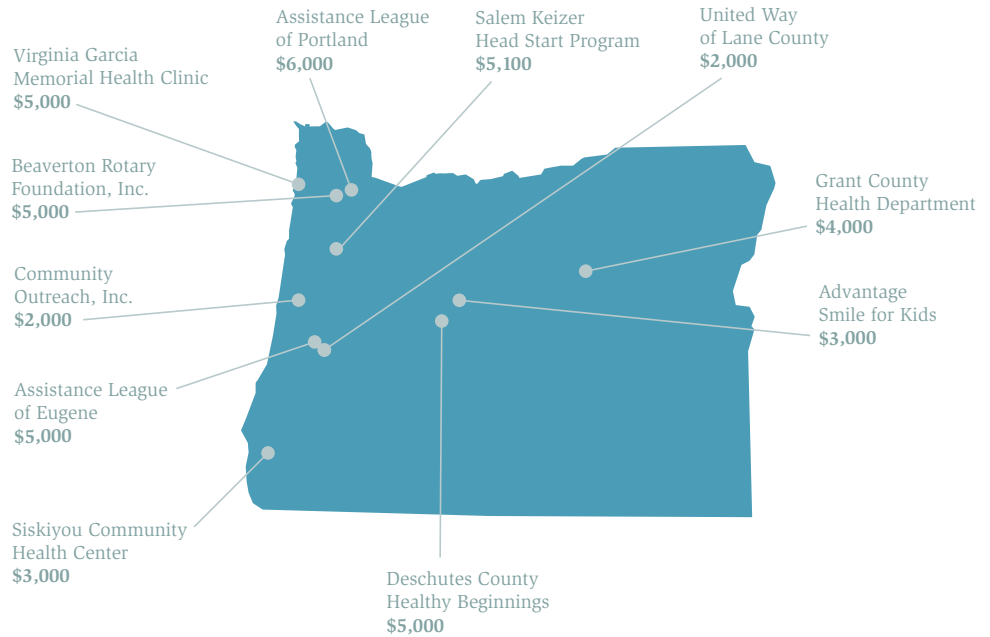

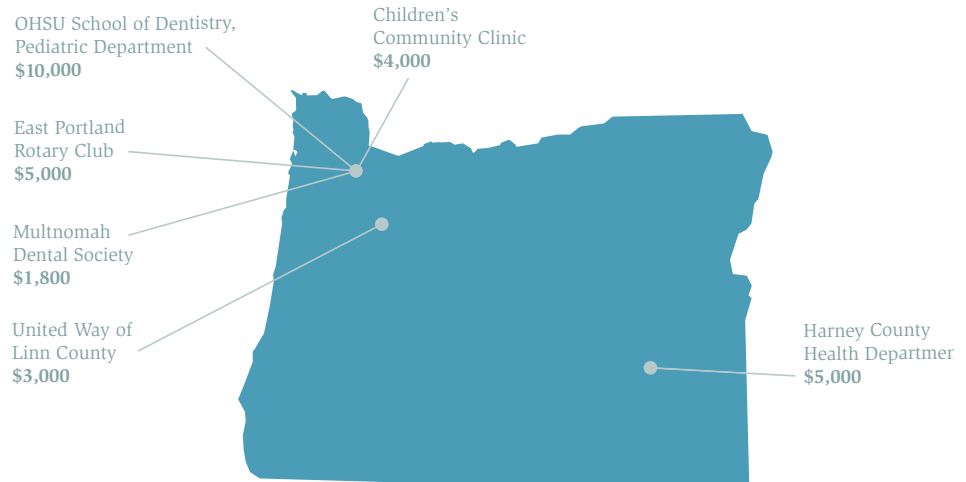
SPRING GRANT DISTRIBUTION

2007 GRANT SPOTLIGHT: HARNEY COUNTY HEALTH DEPARTMENT

The Harney County Health Department received a \$5,000 grant from the foundation to enhance its existing Early Childhood Development program.

The program aims to reduce the risk of cavities in low-income children aged 9 – 24 months by providing education, materials, dental screenings and fluoride varnishes. It also educates the parents and/or guardians of these children in prevention practices, including dental hygiene, fluoride supplements and baby bottle tooth decay syndrome.

The program works closely with the Burns Dental Group and the physicians at the High Desert Medical Clinic.





FUNDING THE ORAL HEALTH OF OREGON'S CHILDREN

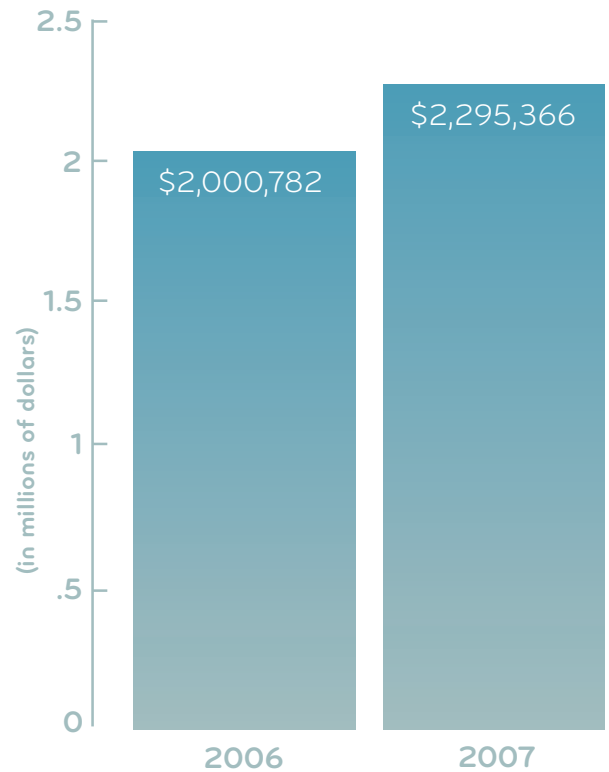
To provide a renewable resource for Oregon children in need of dental care, the foundation invests in a fund under the management of the Oregon Community Foundation (OCF).

Our objective is simple: to grow the fund and serve more children. As our investment grows over time, so does our ability to fund an increasing number of grants — bringing together dental professionals throughout the state with the children who need them.

As the foundation continues to broaden its reach, we are researching ways to invest in ourselves by obtaining grants of our own. All grants received will help finance the operation of our new mobile dental clinic, the Tooth Taxi.

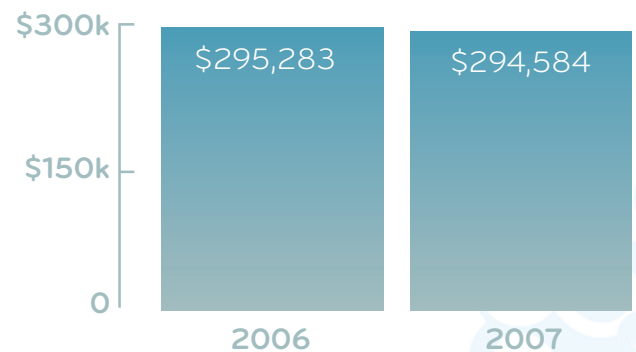
The foundation follows the OCF's grant-giving standards, which ensures the availability of future grant monies by helping the foundation to safely grow its investment, annually distributing 4.5 percent of its earnings to worthy recipients.

Michael J. Goger, DMD

Goger has been an active force in shaping organized dentistry for more than three decades.

He recently retired from The ODS Companies board after serving as a director for 33 years. Although officially retired from his dental practice in Albany, Goger volunteers regularly with Medical Teams International and the Ronald McDonald Foundation of South Dakota to provide treatment to the underserved. In January, Goger spent six days in Ratanakiri, Cambodia, along with five other dentists, two senior dental students, two hygienists and eight support people, providing dental care to patients. In his spare time, Goger enjoys golf, hunting, fishing and traveling. He and his wife Suzann have one daughter.



Steven M. Simmons, DMD

After graduating from OHSU School of Dentistry, Simmons began his dental practice in British Columbia. He spent two

years operating a mobile dental clinic and six years practicing in the Queen Charlotte Islands. Simmons returned to Portland in 1986 and purchased his current downtown general dental practice.

Simmons' prior volunteer experience includes 12 years on the board of the OHSU School of Dentistry Alumni Association, including service as chair of the Centennial Campaign Committee. He was a member of ODA's Annual Meeting Council for four years and spent more than two years on the board of the Multnomah Dental Society. In his spare time, he enjoys fishing and winemaking. He and his wife Anne have three children.
