CONVENTION RAFFLES

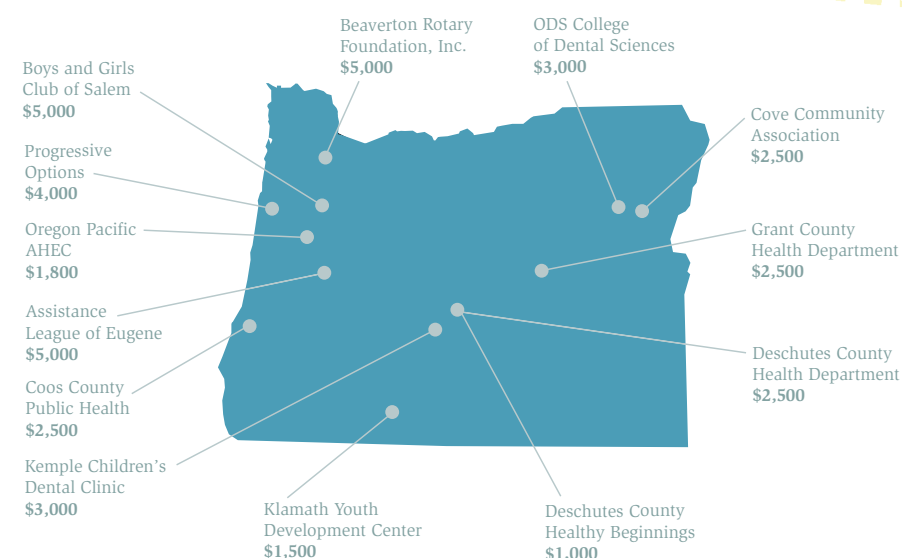

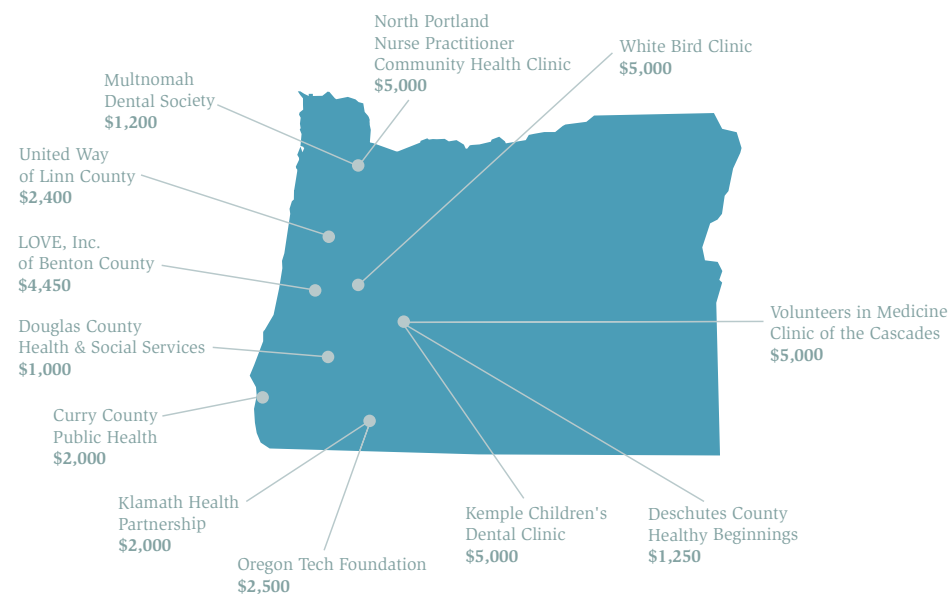
SPRING 2006 GRANT RECIPIENTS

GRANT SPOTLIGHT: KEMPLE CHILDREN'S DENTAL CLINIC

The Kemple Children's Dental Clinic provides emergency dental care to Oregon children from low-income families. The Kemple clinic also works to recruit and encourage other dentists to treat patients covered under the Oregon Health Plan.

Since its inception in 1998, the foundation has awarded the clinic approximately \$60,000 in grant monies, helping to treat nearly 6,000 children in need of dental care.

The Kemple Children's Dental Clinic was the 2006 recipient of the foundation's George A. Ronning Humanitarian Award. The award is given in memory of George A. Ronning, DMD, a model dentist, statesman, teacher and outstanding humanitarian.

INVESTMENT POLICY

INVESTING IN THE FUTURE OF OREGON'S CHILDREN

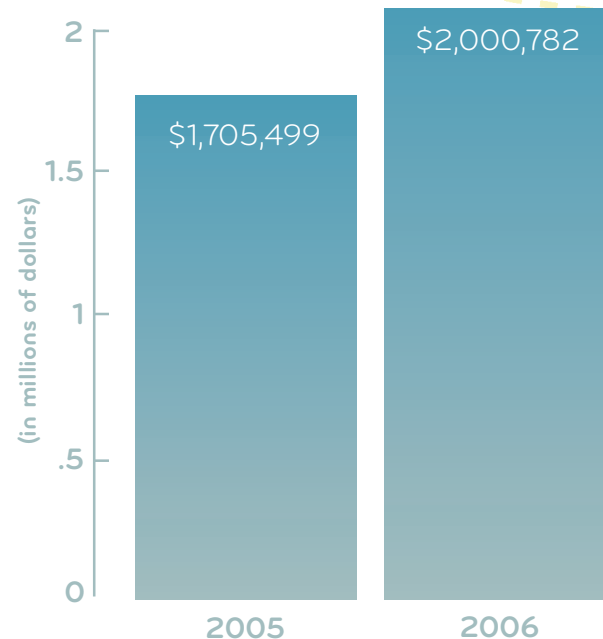
In order to provide a renewable resource for Oregon children in need of dental care, the foundation invests in a fund under the management of the Oregon Community Foundation (OCF).

Our objective is simple: to grow the fund and serve more children. As our investment grows over time, so does our ability to fund an increasing number of grants — bringing together dental professionals throughout the state with the children who need them.

The fund, established in 2001, passed the \$2 million mark in 2006 thanks to generous corporate and private donations, along with earnings invested from our annual fundraising events.

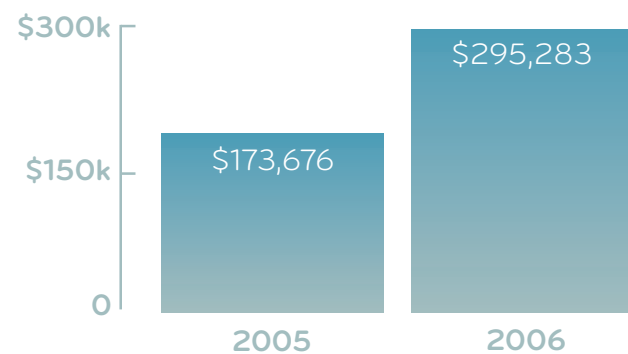
The foundation follows the OCF's grant-giving standards, which ensures the availability of future grant monies by helping the foundation to safely grow its investment, annually distributing 4.5 percent of its earnings to worthy recipients.

INVESTMENT FUND GROWTH



In 2006, the foundation's investment fund reached a milestone, passing the \$2 million mark with significant growth throughout the year. One of the reasons for this increase was a successful fundraising year, resulting in a 40 percent increase in fund deposits.
